



The provider submitting the most economically advantageous bid in conjunction with the highest quality score achieved in mini competition will be awarded the contract. Either partner can also be appointed as a full multi-disciplinary team.

DIRECT AWARD - BY LEAD SUPPLIER

A direct award can be made to Mace or Corstorphine & Wright without further competition for services within their lot.

Lot 2: Mace are the lead supplier for cost, project, and programme management

Lot 3: Corstorphine & Wright are lead supplier for design, engineering and surveying and strategy.


DIRECT AWARD - ALLIANCE OFFER
